BYLAW NO. 2006-MC-15

A BYLAW OF THE TOWN OF MAPLE CREEK TO LICENSE CERTAIN PERSONS ENGAGED IN BUSINESS IN THE TOWN OF MAPLE CREEK

The Council of the Town of Maple Creek, in the Province of Saskatchewan, enacts as follows:

1. This bylaw shall be called the "Licensing Bylaw."

2. **INTERPRETATION:**

In this Bylaw the words:

- a. "Business," "Resident," and "Transient Trader" shall have the same meaning as they have in the *Municipalities Act*.
- b. "Town" shall mean the Town of Maple Creek.
- c. "Contractor" shall mean and include any person, persons, firm or corporation that contracts or covenants to do a specific thing for another person or who makes a business of executing work according to a contract and/or construction for future sale to another person.
- d. "License Inspector" shall mean the license inspector appointed by the Council of the Town of Maple Creek.

3. APPOINTMENT OF LICENSE INSPECTOR

The Council of the Town of Maple Creek shall appoint a License Inspector who shall be responsible for the administration of this bylaw.

4. LICENSE FEES

The license fees payable in respect of a business license shall be the amount set forth in Schedule "A" and shall be paid at the Town Hall before the license is issued.

Where not specifically provided for in the above schedule of fees, a monthly license may be issued. The fee for such shall be 15% of the annual amount. If the business receiving a monthly license wishes to convert it to an annual one in the same calendar year, the money paid for the monthly license shall be considered as payment towards the annual fee.

5. **CERTAIN BUSINESSES EXEMPT**

Any business operating in the Town of Maple Creek which operates from property that is assessed as Commercial for the purposes of taxation, shall be exempt from the license requirements detailed in this bylaw; however, no exemption from any other licensing or certification requirement that any other authority may impose is granted or implied.

6. **GRANTING OF LICENSES**

Subject to the Direct Sellers Act:

- a. In the case of new licenses, the application may be referred for approval to the General Government Committee who may refer it to the Council.
- b. In the case of any application for the renewal of licenses, the License Inspector or their designate shall grant the renewal.

- c. Notwithstanding the foregoing, where Provincial Certification, a Provincial License or a performance bond is required, no license shall be granted until such certification, license or bond has been acquired.
- d. Where a license has been granted, a license substantially the same as contained in Schedule "B" shall be issued.

7. **DURATION OF LICENSE**

Every business license shall expire on December 31st of the year in which it was issued unless it is otherwise specifically provided in Section 10 "That the license shall be for some other period of time."

8. TRANSFER OF LICENSE

There is no provision in the Urban Municipality Act for transferring business licenses.

9. **DISPLAY OF LICENSE**

Every person granted a license to carry on business in the Town shall keep the license displayed in a conspicuous place or shall carry it on his person while engaged in that business.

10. REFUSAL, SUSPENSION OR REVOCATION

The Council may refuse, suspend or revoke a business license in good faith, without discrimination and in the public interest and where a license is revoked the licensee is entitled to a refund of part of the license fee proportionate to the unexpired term of the license.

No license shall be suspended or revoked until the license has had an opportunity to appear before Council and state reasons why his license should not be suspended or revoked.

11. PENALTY

Any person who, upon summary conviction, is found guilty of a breach of the provisions of this bylaw, shall be liable to a fine of not less than Two Hundred Dollars (\$200.00) nor more than Two Thousand Five Hundred Dollars (\$2500.00).

Fines levied under this section may be paid voluntarily, to the Administrator, Assistant Administrator or Office Clerk, at the Town Office within seventy-two (72) hours of receiving the fine.

- 12. Bylaw No. 2000-MC-18 is hereby repealed.
- 13. This Bylaw shall come into force and effect upon final passing by the Council of the Town of Maple Creek.
