BYLAW NO. 2018-MC-13

A BYLAW OF THE TOWN OF MAPLE CREEK TO AMEND BYLAW # 2010-MC-02 KNOWN AS THE ZONING BYLAW.

WHEREAS the Government of Canada has legalized the cultivation and sale of cannabis.

WHEREAS the Province of Saskatchewan has approved the Town of Maple Creek as a location for cannabis business.

WHEREAS the Town of Maple Creek wishes to regulate where a cannabis business is permitted to operate within the community.

THEREFORE the Council of the Town of Maple Creek, in the Province of Saskatchewan, enacts the following amendments to Bylaw # 2010-MC-02 in order to regulate where a cannabis business is permitted to operate within the community.

- 1. Section 6.4.3 C1 Discretionary Uses is amended by adding 6.4.3(f): "Cannabis retail stores"
- 2. Section 6.4.4.3 C1 Development Regulations is amended by adding 6.4.4.3(f): "Cannabis retail stores must be located a minimum of one block (as defined at Council's discretion) from schools & playgrounds."
- 3. Section 6.5.3 C2 Discretionary Uses is amended by adding 5.5.3(e): "Cannabis cultivation & retail stores"
- 4. Section 6.5.4.3 C2 Development Regulations is amended by adding 6.5.4.3(c): "Cannabis cultivation & retail stores must be located a minimum of one block (as defined at Council's discretion) from schools & playgrounds."
- 5. Section 6.6.3 M1 Discretionary Uses amended by adding 6.6.3(i): "Cannabis cultivation"
- 6. Section 6.6.4.4 M1 Development Regulations is amended by adding 6.6.4.4(f): "Cannabis cultivation must be located a minimum of one block (as defined at Council's discretion) from schools & playgrounds."

This Bylaw shall come into force and effect upon the third and final reading by the Council of the Town of Maple Creek.

- 4. Section 6.5.4.3 C2 Development Regulations is amended by adding 6.5.4.3(c): "Cannabis cultivation & retail stores must be located a minimum of one block (as defined at Council's discretion) from schools & playgrounds."
- 5. Section 6.6.3 M1 Discretionary Uses amended by adding 6.6.3(i): "Cannabis cultivation"
- 6. Section 6.6.4.4 M1 Development Regulations is amended by adding 6.6.4.4(f): "Cannabis cultivation must be located a minimum of one block (as defined at Council's discretion) from schools & playgrounds."

REASON:

The reason for the amendment is to regulate where a cannabis business is permitted to operate within the community.
