Re: 2019 SAMA Municipal Invoice

The invoice accompanying this letter represents your municipality's share of SAMA's 2019 operating revenues. This share is based on the cost of service formula adopted by SAMA in 1996 and updated by the SAMA Board in 2013 for the new service fee implemented in 2015.

The 2019 SAMA Municipal Invoice includes a 2% increase to the charge per property (in accordance with SAMA's four-year business plan) and updates the property counts. There was no change this year to SAMA's \$20 fee-for-service on property reviews or the technology maintenance charge.

With our clients and the Province, SAMA invested in updated technology from 2014-17 and this was instrumental in the agency increasing its output of property reviews from less than 50,000 in 2013 to 105,616 in 2018. After factoring in all changes, the total charge to SAMA's municipal clients will be increasing 1.7% or \$142,000 in 2019, moving from \$8.554M in 2018 to \$8.696M in 2019.
